Meditation: Pray Till You Pray By Paul Levy

The following is from the Church and Nation Committee report for Synod 2025, compiled by the convenor, George Ball.

To encourage us in prayer, the following is a quote from Paul Levy's monthly letter to the congregation of The International Presbyterian Church, Ealing, West London, in Nov. 2024.

I am reading the biography of the 19th Century Scottish Minister Alexander Moody Stuart. He was part of a golden generation of Scottish Ministers which included Robert Murray McCheyne and the Bonar brothers, that did so much good for the gospel. Moody Stuart gave 3 instructions on prayer which I've found helpful:

- 1. Pray till you pray
- 2. Pray till you are conscious of being heard
- 3. Pray till you receive an answer.

This is helpful to us because there is a recognition here that prayer is not always easy. Very often it can feel as if we are going through the motions, rattling through a list. Lists are helpful for prayer. I was once bemoaning them, when my mother said to me, 'when you go to the shop, do you find a list restrictive?' It's a great point that when I go to the shop, I make sure I have a list to remind me what I need. However, the danger in prayer is we go onto autopilot, and we think we've prayed by going

Moody Stuart recognises that we need to pray until we pray. That is, in prayer we are engaging with God, seeking to bring our utter impotency before him. It is the practical expression of our need, without him we cannot work, we have nothing. There is a reliance and dependence on God which gives expression to prayer. It is a recognition that we need God and God is one who has drawn near, who is able, who does act, who does love and who gives. Our hearts are stirred as we bring before him his character and his nature, and we are reminded of our privilege.

We move from going through our list to realising we are in the presence of God, that his Son is interceding for us. His Spirit bears witness with our spirit that we are children of God, and it is at that point we can, "pour out our hearts before him" (Psalm 62:8). We need not, nor can we hold anything back from him. We are coming to one to whom all hearts are open, he knows us, he understands us and yet he loves us passionately. He delights to hear us pray.

This takes time. In our human relations, if we are to have important conversations, we know that we must give time to them; put the phone down, get away from the screens. It is no different with God. It is why Jesus tells us to go into our closet (Matthew 6:6).

We need to see how cold our hearts often are. They need to be warmed by God's love and grace in his Son. It is by engaging with God in his Word and prayer that the ice of our hearts is melted. As our minds and hearts understand the love of God in Christ, our affections are stirred and our wills motivated. We become conscious that our every moment is lived before God by his Spirit.

Moody Stuart's second instruction is to pray until you are conscious of being heard.

Having prayed until we pray, recognising who God is and what he's done, understanding his heart for sinners, appropriating his love for his people; we then become conscious that he has heard us. At times in conversation people will say, 'I don't want you to do anything — I just want you to listen'. It's often a cry of anguish, where someone feels they haven't been heard. It is a horrible thing for one to feel that their voice is not listened to . . .

It is possible to be in a conversation where you are speaking with people and you become conscious that they are not listening; but that is never the case with God. Moody Stuart instructs us to pray until we are conscious that God has heard us.

His third instruction follows on from this – pray until you receive an answer.

We know he does not always answer, 'yes'. He sometimes says, 'no', and often he says, 'wait'; but we must get to the point where we are aware he has heard and answered. The call to prayer is a call to perseverance – Jesus tells us

to 'ask, seek, knock (Matthew 7:7-12)', to keep on asking (Luke 11:8) . . . and to not give up (Luke 18:1-8).

There are many times when God is asking us to wait, and the temptation for us is to give up. Like you, there are people I have been praying for, for decades. I can think of one non-Christian friend who I think we have prayed for most days over 25 years and yet she has still not trusted Christ. I can often feel ashamed about asking the same thing over and over again, but God encourages me to do that. The we have prayed something the more difficult it is to keep going, but the life of faith is one that says we will not go away, we will keep knocking, we will keep asking. God has given us this right and privilege to come to him - he is not fed up with us. Our asking will get bolder, our seeking will be more intense, our knocking will become louder. Do not give up praying for people.

One last thing, it is tempting to read this and privatise it. Private prayer is essential: Jesus commands it, but it would seem that corporate prayer – where the church gathers together to pray – is most prevalent in Acts. These truths of, 'praying until we pray, pray until we are conscious of being heard, and pray till we receive an answer', are as applicable to our church gatherings for prayer. It speaks of an urgency, perseverance, deliberateness and doggedness in prayer. May that increasingly characterise us as a church.

Clippings from the Synod 2025 Minutes

The following clippings "in quotation marks" are taken from the minutes of Synod 2025. Please note: other decisions and minutes are referenced in other articles in this issue, including in the synod prayer points found on pages 9-11.

* * * * * * *

"The [retiring] Moderator [John Forbes] preached on Philippians 3:15-16 under four headings: First, under the heading of rightmindedness, essentials maintained with humility. Second, other-mindedness, or differences exist in the church on nonessentials, this is a reality though not the ideal. Third, we are urged that there be a striving for progress in unity. This takes work, but there is a promise of God granting help. Fourth, that which has been attained should not be given up and ground that is gained, held."

"The [current] Moderator [Jim Klazinga] delivered his opening address on Micah 6, with a focus on verse 8: The Lord brings a charge against His people that cannot be answered. The basis for the charge is found in verse 8, that the Lord requires his people to act justly, to love mercy and to walk humbly, and they do not do it, or regard themselves as already complying. Christ Jesus is the only one that is innocent of the charge of Micah 6 against God's people and fulfils the requirements of verse 8 perfectly. He mediates on behalf and takes the punishment due to us upon Himself."

The moderator, in his morning

devotions, went on to focus on the requirements listed in Micah 6:8, that the Lord requires us to 'do justly' (Wednesday, the 7th of May), 'love mercy' (Thursday, the 8th), and 'walk humbly with your God (Friday, the 9th).

* * * * * * *

It was resolved to add to the Synod Standing Orders (rules that help govern how synod operates), "At the annual meeting of Synod participation by phone or video conference will not normally be allowed. In exceptional circumstances request should be to the Administration Committee in reasonable time before Synod, which may approve the request if it sees fit."

* * * * * * *

It was resolved, "Synod instructs the Law and Advisory examine the Committee to theological principles for the sustentation of the ministry including proposed the introduction of 'PayDay Super' from 1 July, 2026 and to consider the legal and practical implications of any change from our current system, and to bring a report to the 2026 Synod."

* * * * * * *

It was resolved, "That the Synod include the Reformed Theological College, Melbourne in our Synod-approved list of Colleges for candidate training and that the Committee be authorised to enter into a Memorandum of Understanding with the RTC."

* * * * * * *

It was resolved that, "Synod thank John and Judy Greensill for the preparation and continued use of their property, and the Northern Rivers congregation for their generosity for the youth camps over the last several years."

* * * * * *

In regard to ministers taking long service leave, the following were moved, seconded and carried together:

- 1. "Synod approves the establishment of a centralised Long Service Leave (LSL) fund for ministers to ensure financial stability and predictability for congregations.
- 2. "Synod agrees to set aside an initial amount of \$90,000 in a LSL fund to cover current LSL liabilities, and thus authorises the drawing of \$45,000 from the Superannuation Support Fund (SSF) working account, current balance of \$50,414, and \$40,000 from the SSF capital account.
- 3. "Synod agrees to impose an LSL levy on congregations with an ordained minister eligible for LSL, ensuring fair contribution to the fund.
- 4. "Synod approves setting the LSL levy at 0.9 times the weekly minimum stipend to cover LSL entitlements, assuming a 4% annual increase in the stipend.
- 5. "Synod agrees to review the LSL levy annually on January 1st to adjust for changes in stipend rates and ensure the fund remains adequately funded.

- 6. "Synod approves the requirement that applications for LSL leave be approved by the Session and Presbytery, with these approvals reported to the Superannuation and Insurance Committee for monitoring and record-keeping.
- 7. "Synod approves the refund of LSL levy payments to the contributing congregation(s) on a pro rata basis when long service leave is taken."

In response to an overture from Northern Presbytery, it was resolved, "That the wording of Handbook 3.15 and the related Act of 2017 be amended as follows:

"DELETE 'While the ACNC does not require Small Charities to submit a Review or Audit report with their Annual Information Statement, SYNOD requires either a Review or Audit report to form part of the congregation's Annual Financial Report when presenting it to the Presbytery of the bounds for attestation (see 2.33).'

"REPLACE WITH
'Congregations classified as Small
Charities are required by Synod to
have their annual Financial
Statement examined. They may
obtain a professional Review or
Audit or they may appoint as
examiner a competent
independent person who is not a
member of the court."

Regarding this magazine, it was resolved,

- 1. "Synod continues to endorse The Presbyterian Banner as the official magazine of the PCEA.
- 2. "Synod continues to support the

- printing and mailing of the magazine, along with distributing pdf copies by email and making it available on the PCEA website.
- 3. "Synod expresses thankfulness for the assistance of the Presbyterian Banner liaisons from the congregations."

Also concerning publications, it was moved, "That *Purity of Worship* by Rev. M.C. Ramsay be republished. After some considerable and positive discussion, the motion was seconded and carried."

* * * * * * *

"The petition from the Southern Presbytery concerning the sale of Wantirna church building was presented on behalf of the petitioners by Dr Ramsay. It was moved, seconded and carried that the petition be received. Questions were put to the Petitioners.

"Mr Steel presented a motion, which was seconded, that the prayer of the petition be granted in the following terms:

- 1. Permission be granted to Knox (renamed Melbourne) Deacon's Court to sell the Wantirna church situated at 358 Mountain Highway, Wantirna Vic.
- 2. That proceeds from the sale to be held by Melbourne Deacons' Court until the restructuring of the existing centres of worship is completed.
- 3. Melbourne Deacons' Court is then to decide on the application of the proceeds and seek permission for such from Synod in terms of Handbook 3.22

"Upon being put against each

other, Mr Steel's motion was preferred. Upon being put to the vote the prayer of the petition was granted in the terms of the motion. The petitioners were advised of the decision and acquiesced in it."

Regarding the Psalmody Committee, it was resolved "that the Committee be discharged."

Synod again resolved: "The Synod of the Presbyterian Church of Eastern Australia gives thanks to God for the churches with whom we have formal fraternal relations and for those churches with whom we have contact and resolve to pray for the Lord's blessing upon their work and witness."


The following quotations are from the minutes of synod.

"Rev Robin Tso introduced delegates from other churches: Rev. Bruce Backensto from RPCNA; Rev. Sjirk Bajema, RCNZ; Rev. Graeme Hart, RPCA; Rev. David Lachman, SPC; Rev. Samit Kumar, PFCCI, India; Rev. John Nelson, AFC. It was moved seconded and carried that these men be associated with the court. The Moderator advised them of the conditions of association. The Moderator welcomed the delegates to the Synod."

"Rev. Bruce Backensto brought greetings from the RPCNA. The RPCNA is hosting the NAPARC conference this year. The speaker, Chad van Dixhoorn is highlighting the unity that is possible through the Westminster Confession of Faith. Expansion has seen an RPC church established in Canada and there is great vitality in the work in East Asia.


"Rev. Backensto answered questions from the members. Mr Ball led the court in prayer for the work of the RPCNA."



"Rev. Sjirk Bajema brought greetings from the RCNZ. He spoke of the history of the RCNZ from its foundation in Dutch immigration in 1953, integrating with roots in New Zealand Presbyterianism dating back to Dunedin and early Presbyterian churches. Liberal influence in New Zealand led to an exodus to the RCNZ along with immigration from the Continent. In recent years there has been a new influx of South African and Korean folk. The Federation has struggled for 72 years but continues in the strength of the Lord. Mr Bajema asked for prayer for their vacant charges.

"Mr Bajema answered questions from the members. Mr Carswell

led the court in prayer for the RCNZ."



"Rev. John Nelson brought greetings from the AFC. He rejoiced in the good order and zeal he saw in the PCEA and looked forward to union. He reported that the two congregations of the AFC have seen tokens of the Lord's kindness and blessing in recent times, with interest from further afield in Canberra. He was thankful for ecumenical contact with fellow churches and the strong interest and support that the AFC was able to give to mission endeavours. Mr Nelson was hopeful of changes in the political and social fabric of our society in recent times, relying on



the promises of the Lord to never leave nor forsake His people. He encouraged the PCEA to be lights in a dark place, walking by faith and not ashamed of the Gospel."

"Rev. David Lachman brought greetings from the SPC. He reported that they have been observing the work of the PCEA with affection. They have been in prayer for the PCEA in its recent struggles. He has great hope for our mutual blessing because the Lord keeps the church. The

Launceston congregation have been affected by tragic events in the EPC and have had to face huge change. SPC's Hobart congregation has been stable, with their own blessings and challenges. Missions Evening at Synod 2025



Another highlight of synod was the Missions Evening, held in the Wauchope church building on Thursday, the 8th of May.

The next day, it would be resolved: "The Synod gives thanks to the Lord for the opportunity and privilege to be involved in the work of missions at home and abroad, both in giving, in praying, and being directly involved during this past year."

The following is from the minutes of synod.

"The Convener, Dr Muldoon, introduced Rev. Samit Kumar and Mr Pradeep Kumar to the Moderator who welcomed them to the Synod and invited them to speak.

"Rev. Kumar sent greetings from the PFCCI and introduced the presentation. He spoke on the ongoing work of the PFCCI despite challenges. He spoke of the providential way on which they had come to our Synod, due to being hampered from going to a previous engagement in the Netherlands due to Visa delays. Relationships are important and they value the long-standing relationship they have with the PCEA.

"Mr Pradeep Kumar then spoke on the work of the school in wonderful Chhapara and the made progress in developing infrastructure, being able to run new programs including computers and robotics labs. and outstanding results of some students, which heightens the school's reputation and in turn draws enrolment.

Rev. Kumar spoke of the SERVE program being implemented. Strategic approaches are bearing fruit, by God's blessing, church planting work, building infrastructure, in community involvement and in some income generating activities. The PFCCI hopes to conduct its second Synod in November, 2025. There have been some challenges and direct opposition, but the work continues to grow by the Lord's providence and blessing.

12th: It was resolved, "Synod gives thanks and pray for those are involved in the work of teaching Sunday-school and youth classes."

13th: It was resolved, "Synod thank Irene Steel for her dedication to the scripture search work and Nic and Amelia O'Dell for birthday card greeting and uphold them in prayer."

22nd: It was resolved. "That the Synod commend the **PCEA** website to delegates and congregations and they be encouraged to participate in the life of the church online by active registration, collaboration comment." Pray for the website, and for the work of David Kerridge as webmaster.

23rd: "The Clerk of Presbytery, Mr John Forbes, presented the Northern Presbytery report." Pray for the Northern Presbytery.

24th: "The Clerk of Presbytery, Mr Ian Miller, presented the Central Presbytery Report." Pray for the Central Presbytery.

25th: "The Clerk of Presbytery, Mr Donald Ramsay, presented both the 2023 and 2024 reports for the Southern Presbytery." Pray for the Southern Presbytery.

26th: "The Convener, Dr Muldoon, introduced Rev. Samit K and Mr Pradeep K to the Moderator who welcomed them to the Synod and invited them to speak." Give thanks that Samit and Pradeep could visit our synod and report on their ministries in India.

27th: It was resolved, "The Synod gives thanks to the Lord for the opportunity and privilege to be involved in the work of missions at home and abroad, both in giving, in praying, and being directly involved during this past year."

28th: It was resolved, "Synod

thanks the congregations that held mission events during the year and urges all congregations to consider inviting mission workers in person, or online, to give an update of their ministry, and field questions from church folk. Presbyteries could assist or coordinate." Pray for opportunities for our congregations to learn more about mission works around the world.

29th: It was resolved, "To assist in determining whether the Reformed Protestant Mission - Sri Lanka be included in the current churches/missions and medical work regularly supported Synod, it liaise with Shanmugan NV Partheepan with a view to visiting him to learn more of the work and their needs. If Rev. Partheepan agrees, Rev David Kerridge be appointed to visit him for this purpose at a mutually agreeable time and report back to Synod 2026 via the Missions Committee." Pray for the relationship we hope to develop with this ministry in Sri Lanka.

30th: It was resolved, "That Synod approve the Mission Committee decision to send the Convener, Dr Dennis Muldoon, to the Republic of South Africa to assess and encourage the ministry of the Dumisani Theological Institute and Bible School in King William's Town, with a travel subsidy of \$750 from mission funds." Pray for Rev Muldoon as he prepares to make this visit.

31st: "Rev. David Lachman brought greetings from the SPC." Give thanks for Rev. Lachman's attendance at our meeting, and

pray for our relationship with the Southern Presbyterian Church.

"Alex Steel has (again) submitted his resignation General Treasurer. Having fulfilled the role of Assistant Treasurer, Donald Ramsay is expected and nominated to take on the role of General Treasurer. Mr Steel's resignation was accepted by the Synod with thanks and Dr Ramsay appointed as General Treasurer." Give thanks for Alex Steel's faithful work as treasurer, and pray for Donald Ramsay as he serves in this role.

33rd: It was resolved, "That synod thank the assessors to Southern Presbytery who have worked diligently within that presbytery over the last several years- Rev John Forbes, Rev Dennis Muldoon, and Tom Reeve. And that synod review the assessors and appoint Rev Jim Klazinga and Rev Robin Tso and Rev George Ball as assessors." Continue to pray for the Southern Presbytery.

34th: It was resolved, "that Mr Tso be the Moderator-Elect for 2026." Pray for Robin as he prepares to take on this task.

35th: "It was agreed that the next Annual Synod take place in the Wauchope Church of the Hastings River Congregation from Tuesday 5th to 8th May, 2026." "A vote of thanks was expressed to the Hastings River Congregation for their kind hospitality and carried by acclamation." Pray for Hastings as they prepare to host synod again next year.
